SUBJECT: *Revised Digger Derrick standard ANSI/ASSE A10.31-2013*

Issue:

ANSI/ASSE A10.31-2013 – Safety Requirements, Definitions and Specifications for Digger Derricks.

The standard which applies to Digger Derricks has been revised. ANSI/ASSE A10.31-2013 is effective September 1, 2014. This is an update to the previously issued ANSI/ASSE A10.31-2006 standards. The standard has requirements for everyone involved in Digger Derrick design, manufacture, installation, maintenance, ownership, use, and operation. This version replaces all previous versions for the responsibilities of; installer, owner, user, operator, lessee or lessor and broker. Machines manufactured under previous ANSI standards do not have to be updated, but the Responsibilities of the; Installers, Owners, Users, Operators, Lessors or Lessees, and Brokers require compliance with this current version.

Failure to comply with your required responsibilities in the maintenance, safe use, and operation of the Digger Derrick could result in Death or Serious Injury.

Action:

It is advisable to obtain a copy of the newly revised standard to determine what is required for you and your company to comply with the standard. This standard also applies to maintenance, use, and operation of Digger Derricks made under previous A10.31 standards. Read the standard to determine if your units and their use will be affected.
