Meanwhile, when Genuine components are fitted you can be assured the part will fit and work perfectly first time and indeed is the latest version approved by Engineering. Genuine MDS parts have the potential to improve the machines performance, increase production uptime and therefore financial return.

There are many imitations of parts and components on the market that appear to be applicable for MDS machines. However, these parts have not undertaken rigorous testing to ensure safety and optimal functionality. This is why MDS provide a 12-month guarantee with their genuine parts, to assure customers that they are purchasing quality parts that will last. Genuine parts aren't a replacement, they are an upgrade in efficiency and an investment in safety.
